# Witches Woods Tax District Board of Directors Minutes July 2nd, 2025, 6:30 pm

Members met in person at the home of Bill and Susan Breslau.

**Members Present:** Mike Moran, Phyllis Bonneau, Ray

Bonneau, Bill Breslau, John Barber, Tony Paradiso, Anna Barrasso, Bob Andrews. Shari McCarthy joined via Zoom at 7:30 pm. Guests present: Lisa Andrews, Grace Baril.

President Mike Moran opened the meeting. A motion was made and seconded to approve the board minutes from last month.

Guest Lisa Andrews shares that our 3rd annual party is on schedule for this Saturday, a porta-potty will be delivered to the Crooked Trail Beach area this Thursday, and will be picked up on Monday. Approximately 60 people have responded and will be attending.

## **Reports of Committee Chairs:**

#### Lake, Dam, and Beaches - John Barber

- The dead tree on Indian Spring Road Beach was cut down safely
- Phosphorus Testing- Water samples were taken from the following lake locations. They were brought to Phoenix Laboratories in Manchester and tested for total phosphorus. Normal phosphorus levels in lake water generally fall below 0.03 mg/L (milligrams per liter) for total phosphorus. Higher levels can lead to increased growth of plants and algae. Only the north cove was over 0.03 mg/L.
  - North Cove 0.047 mg/L
  - Spillway from Lake Bunggee: 0.022 mg/L
  - o South Cove: 0.016 mg/L
- John has received complaints regarding weeds in the lake and presents the following survey report dated June 20th from Solitude Lake management. The survey results indicate that the current growth is within normal limits, and the lake management company does not recommend treatment at this time. The following is a copy of the email sent to John:
  - Please see the attached survey map completed on June 20, 2025. This map shows the approximate locations where the invasive submerged Slender Pondweed was observed (current conditions may vary).



- Guest Grace Baril interrupts John at this point with concern regarding the cattails around her son Paul's dock, stating that there are many more here than on any other properties.
- John continues his report advocating for more frequent mowing in the area of Crooked Trail extension and an effort to avoid overgrowth in this area.
- Guest Grace Barrel continues to express her worry about the state of the weeds in the lake, the near shore weeds/cattails, fertilizers/phosphates in the lake, conflicts between her son and a neighbor, the watercourse along the side of her son's property, allegations regarding the paving project at the 'T' entrance to the lake of Rt 171, allegations regarding fines levied to her son, a petition she has brought forward to the board regarding water quality in the lake, the insurance that is part of the lakes budget each year, as well as concerns regarding culverts and 'phase 3' of a road project. In response to these concerns:
  - President Mike Moran assures Mrs Baril that the board is very conscientious about the state of the lake. He further explains that each property on the lake contains a drainage easement that belongs to the district.
  - o Bill Bresleau explains that there is nothing in the original Covenant barring fertilizers, but rather similar language to what is present today as a set of rules. He further tries to explain that healthy lakes have native plants whose roots pull chemicals out of the lake, such as the plants present between two properties. As the head of the Safety Committee, Bill continues to explain the importance of the insurance that the lake holds to protect homeowners' interests and protect the whole lake community against liability should anyone be hurt anywhere on the property.
  - John also volunteers to look into the impact independent professional lawn treatment may have on lake health. Tony states it is important that any professional opinion takes into account the fact that most of our water comes from Lake Bungee. Again, the board discusses the options available to levy fines, which, when not paid, can be attached to taxes, and if these are not paid, can lead to a lien on the property.
  - After nearly an hour-long discussion, Tony addresses Grace, stating that this discussion is very circular, and it is clear that no resolution will be had today. He indicates that the Board needs to move forward with the scheduled agenda for the evening.
  - President Mike Moran promises Grace a written response to her various concerns. He states he will draft one for the board to review and send it along to her as soon as each of the members has a chance to give feedback. He states it is of utmost importance that the information in the response be factually correct and reflective of the board member's views. He further thanks Grace for her obvious passion in maintaining a healthy lake community.
